CONSUMER PRICE INDEX FOR ALL INCOME HOUSEHOLDS IN CATANDUANES, 2012=100: JUNE 2019

PRICE SITUATION: Year-on-Year

Inflation Rate (IR) in Catanduanes increases to 1.9 in June 2019

The Inflation Rate (IR) in the province of Catanduanes for June 2019 settled at 1.9 percent which translates to a Purchasing Power of the Peso of P 0.85. It is higher than the registered IR of 1.6 percent in May 2019. It is also lower by 3.8 points than the registered inflation rate of 5.7 in the same period last year.

The CPI for all Income Households in all items in Catanduanes for the month of June 2019 registered at 118.3 index points which is higher than last month's registered index points. It was higher than the 116.1 price index points registered at the same period last year.

PRICE SITUATION: Month-on-Month

Vegetables commodity group has the highest increase in CPI for June 2019

The Food and Non-Alcoholic Beverages commodity group recorded a 122.8 consumer price index points during the month of June 2019 which is the higher compared to last month's recorded price index points of 122.0. Vegetables commodity group had the highest increase in CPI recorded at 2.8 price index points. Other commodity groups that recorded an increase in price index points during the month were Meat (1.8); Milk, Cheese and Eggs (0.7%); Rice (0.7%); Oils and Fats (0.5%); Sugar, Jam, Honey, Chocolate and Confectionery (0.4%); Food Products N.E.C. (0.4%); Bread and Cereals (0.3%); Fish (0.2%); and Other Cereals, Flour, Cereal Preparation, Bread, Pasta and Other Bakery Products (0.1%).

Corn commodity group has the highest decline in CPI in June 2019

CPI for Corn commodity group in June 2019 had the highest decrease recorded at 10.7 price index points. Fruit was the other commodity group that experienced decrease in price index points during the month with 1.8%.

Non-alcoholic beverages commodity group registered an increase in price index points of 0.7%.

Alcoholic, Beverages and Tobacco commodity group records increase in CPI for June 2019

CPI for Alcoholic, Beverages and Tobacco commodity group in June 2019 increased at 167.2 from 165.5 CPI recorded in May 2019.

Clothing and Footwear commodity group headlines non-food commodity groups that experienced increase in CPI in June 2019

Non-food Commodity Group that recorded an increase in price index points during the month were Clothing and Footwear (1.3%); Recreation and Culture (1.2%); Health (0.8%); Restaurant and Miscellaneous Goods and Services (0.2%); and Furnishings, Household Equipment and Routine Maintenance of the House (0.1%).

Transport commodity group recorded a 1.3% decrease in CPI for June 2019. Other commodity group that record decrease in CPI for June 2019 was Housing, Water, Electricity, Gas and Other Fuels (0.6%).

Communication and Education commodity groups did not experience any changes in price index points during the month.

2012=100 June 2018 and June 2019**

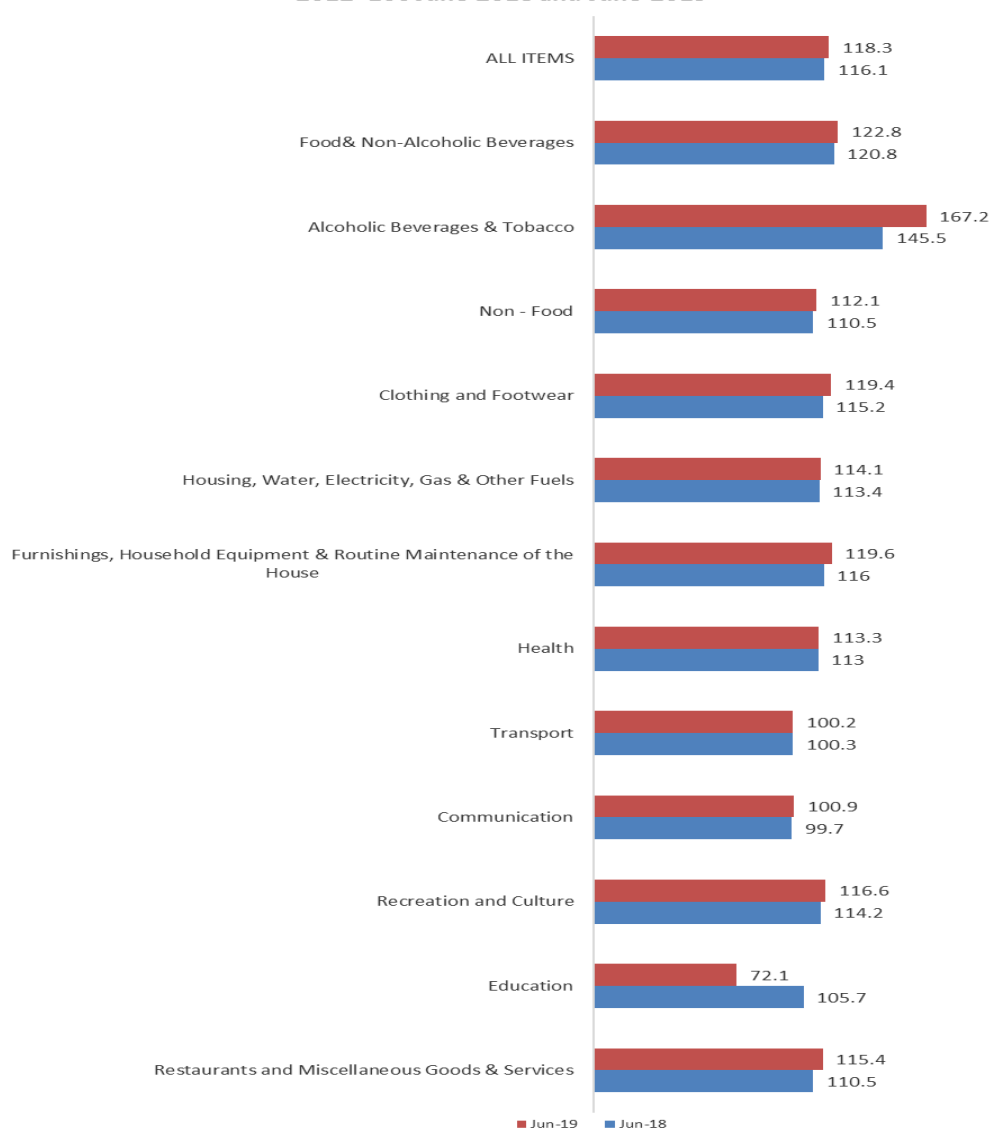
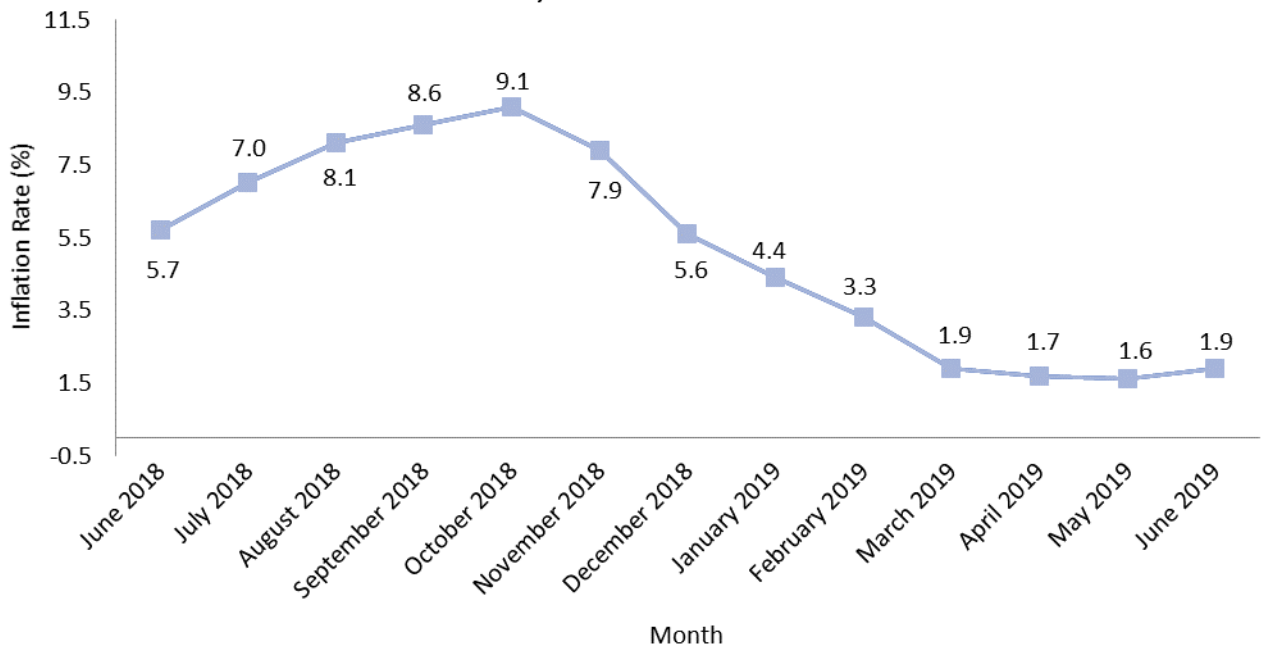


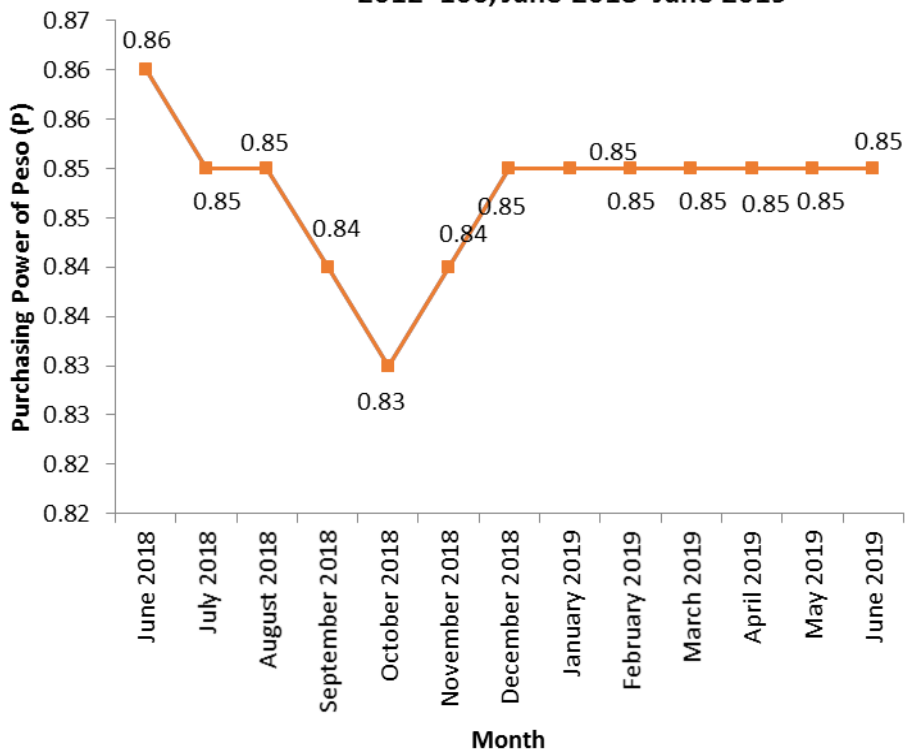

CONCEPTS AND DEFINITIONS

CONSUMER PRICE INDEX (CPI):

- * A measure of the changes in the average price level of goods and services that most people buy for their day-to-day consumption.
- * It measures the composite change in the consumer prices of various commodities over time.

COMPONENTS OF THE CPI:

- * *Market basket* -- A sample of the variety of goods and services commonly consumed by an average Filipino household to represent the price behavior of all goods and services bought by consumers.
- * *Weight* - Value attached to a commodity or group of commodities depending on the magnitude of its contribution to the index.
- * *Base period* -- A reference date at which the index is equal to 100. Base year is 2012.
- * *Sample outlets* -- Establishments where prices of commodities are quoted.
- * *Index methodology* -- Laspeyre's formula = Fixed base year and weights.

INFLATION RATE:

- * It is the annual rate of change or the year-on-year change in average retail prices.

PURCHASING POWER OF THE PESO (PPP):

- * It shows how much the peso in the base period is worth in the current period.
