

BAC Resolution Declaring Lowest Calculated and Responsive Bid for the Procurement of Supplies and Materials for the 2024 Census of Population and Community-Based Monitoring System (2024 POPCEN-CBMS) Lot 2

WHEREAS, the Philippine Statistics Authority Bids and Awards Committee posted the Invitation to Apply for Eligibility and to Bid for the Procurement of Supplies and Materials for the 2024 Census of Population and Community-Based Monitoring System (2024 POPCEN-CBMS) on the Philippine Government Electronic Procurement System (PhilGEPS) and Philippine Statistics Authority official website (PSA.gov.ph and rso05.psa.gov.ph), continuously from June 10, 2024 to July 1, 2024;

WHEREAS, on June 18, 2024, the Bids and Awards Committee (BAC) held the Pre-bid Conference which was attended by four (4) prospective bidders;
